THROUGH A GIFT ANNUITY IT IS NOW POSSIBLE TO:

- Have a lifetime income for one or two people from the monies invested.
- Have the immediate benefit of a tax deduction the year you make the gift.

HOW?

By making a GIFT ANNUITY.

A gift annuity is an irrevocable financial agreement between you and Jews for Jesus. You make a gift to the ministry and we agree to give you an income for the rest of your life.

HOW DO YOU CALCULATE THE INCOME?

These rates change periodically. We will send you a specific proposal when you fill out the attached coupon. The rates below were valid when this brochure was printed.

HOW DOES IT WORK?

Let me tell you about the Johnsons.

Mr. and Mrs. Johnson have just retired. Jim is 65, Sarah is 60 and they decide to set up a Gift Annuity with a gift of \$10,000. They complete some simple documents and in exchange for their gift they will receive an income of \$550 each year as long as either are living. Over \$300 of that income is tax free for 27 years! Also the Johnsons will have the benefit of a \$1,355 tax deduction in the year they make the gift.* When the Johnsons go to be with the Lord, the funds are released to be used in the evangelistic work of the ministry.

Over a decade ago, Jews for Jesus established an endowment fund, the Jewish Christian Ministry of Reconciliation (JCMR). All funds received by Jews for Jesus from gift annuities go into this fund unless the donor specifies otherwise. Jews for Jesus uses the income from the fund for its evangelistic programs, but leaves the principle to earn income for the future. This enables donors to continue supporting Jewish evangelism when they have gone to be with the Lord.
